Meet your new doctor. His name is Tedros Ghebreyesus.

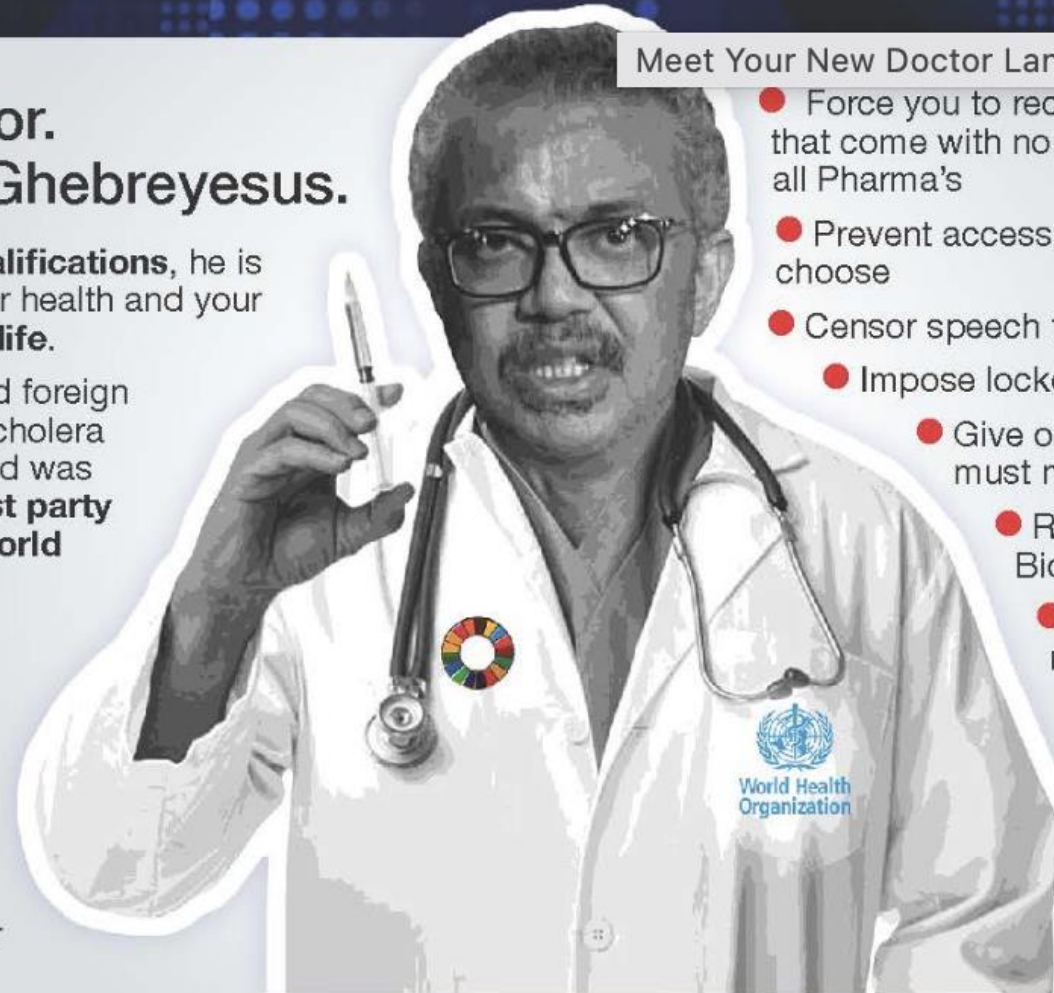
Despite having **ZERO medical qualifications**, he is about to become the arbiter of your health and your family's health for the **rest of your life**.

Two Documents

Pandemic Agreement (Treaty, Accord. Ca++)



International Health Regulations are an instrument of international law that is legally-binding on 196 countries, including the 194 WHO Member States. IHR require that all countries have the ability to detect, assess, report, and respond to public health events. Originally adopted in 1969, amended 2005.

The World Health Organization (WHO)'s 194 member nations are being asked to vote on two documents in the last week of May that will transfer unprecedented powers from our nations to the World Health Organization. Here's what is happening:

- A new **Pandemic Treaty** is being proposed that would legalize the worldwide use of experimental, liability-free vaccines, impose health censorship and much more.
- Major amendments to the **International Health Regulations** are being proposed that give the **WHO** the power to impose worldwide lockdowns, vaccine mandates and much more.

If either one of these two documents passes, it will be a **massive blow** to our civil rights, our Constitution, our national sovereignty and our individual freedoms. Both documents are considered international treaties and are intended to be enforceable.

1. Nations will be **forced** to pass laws to allow unlicensed, rapidly-produced and liability-free vaccines to be used for future pandemics.
2. The WHO will be able to order global **vaccine mandates, lockdowns, quarantines and border closures**.
3. The WHO Director-General (**who isn't a physician**) would decide which treatments you will get, which treatments you will be prevented from getting, and which information you and your doctor will be allowed to see.
4. The WHO will require nations to surveil their citizens' online activities and **ensor** all information that does not agree with the WHO's health narratives.
5. The WHO is building a **biowarfare** agent library: requiring that nations share "potential pandemic pathogens" (a.k.a. biological warfare agents), decode their genomes in high containment labs, and place their sequences online in public databases - virtually guaranteeing lab escapes and more pandemics.

Amendments to IHR

Article 1 Definitions

1. For the purposes of the International Health Regulations (hereinafter “the IHR” or “Regulations”):

“standing recommendation” means ~~non-binding~~ advice issued by WHO for specific ongoing public health risks pursuant to Article 16 ~~regarding appropriate~~ health measures for routine or periodic application needed to prevent or reduce the international spread of disease and minimize interference with international traffic;

“temporary recommendation” means ~~non-binding~~ advice issued by WHO pursuant to Article 15 for application on a time-limited, risk-specific basis, in response to a public health emergency of

Amendments to IHR

Article 2 Scope and purpose

The purpose and scope of these Regulations are to prevent, protect against, prepare, control and provide a public health response to the international spread of diseases including through health systems readiness and resilience in ways that are commensurate with and restricted to ~~public health risk~~ all risks with a potential to impact public health, and which avoid unnecessary interference with international traffic ~~and trade~~, livelihoods, human rights, and equitable access to health products and health care technologies and know how.

Amendments to IHR

Article 18 Recommendations with respect to persons, baggage, cargo, containers, conveyances, goods and postal parcels

1. Recommendations issued by WHO to States Parties with respect to persons may include the following advice:

- no specific health measures are advised;
- review travel history in affected areas;
- review proof of medical examination and any laboratory analysis;
- require medical examinations;
- review proof of vaccination or other prophylaxis;
- require vaccination or other prophylaxis;
- place suspect persons under public health observation;
- implement quarantine or other health measures for suspect persons;
- implement isolation and treatment where necessary of affected persons;
- implement tracing of contacts of suspect or affected persons;
- refuse entry of suspect and affected persons;
- refuse entry of unaffected persons to affected areas; and
- implement exit screening and/or restrictions on persons from affected areas.

Amendments to IHR

Article 44 Collaboration and assistance

2. WHO shall collaborate with and promptly assist States Parties, in particular developing countries upon request, ~~to the extent possible~~, in:

(e) (New) countering the dissemination of false and unreliable information about public health events, preventive and anti-epidemic measures and activities in the media, social networks and other ways of disseminating such information;

Option 5.A

1. The Parties, recognizing that the majority of emerging infectious diseases and pandemics are caused by zoonotic pathogens, commit, in the context of pandemic prevention, preparedness, response and recovery of health systems, to promoting and implementing a **One Health approach, at national, and, as appropriate, at regional and global levels**, that is coherent, integrated, coordinated and collaborative among all relevant actors, with the application of, and in accordance with, domestic law and existing instruments and initiatives.
2. The Parties, with the aim of safeguarding human health and detecting and preventing health threats, shall promote and enhance **synergies between multisectoral and transdisciplinary collaboration** at the national level and cooperation at the international level, in order to identify, conduct risk assessments of, and share pathogens with, pandemic potential at the **interface between human, animal and environment ecosystems**, while recognizing their **interdependence**.

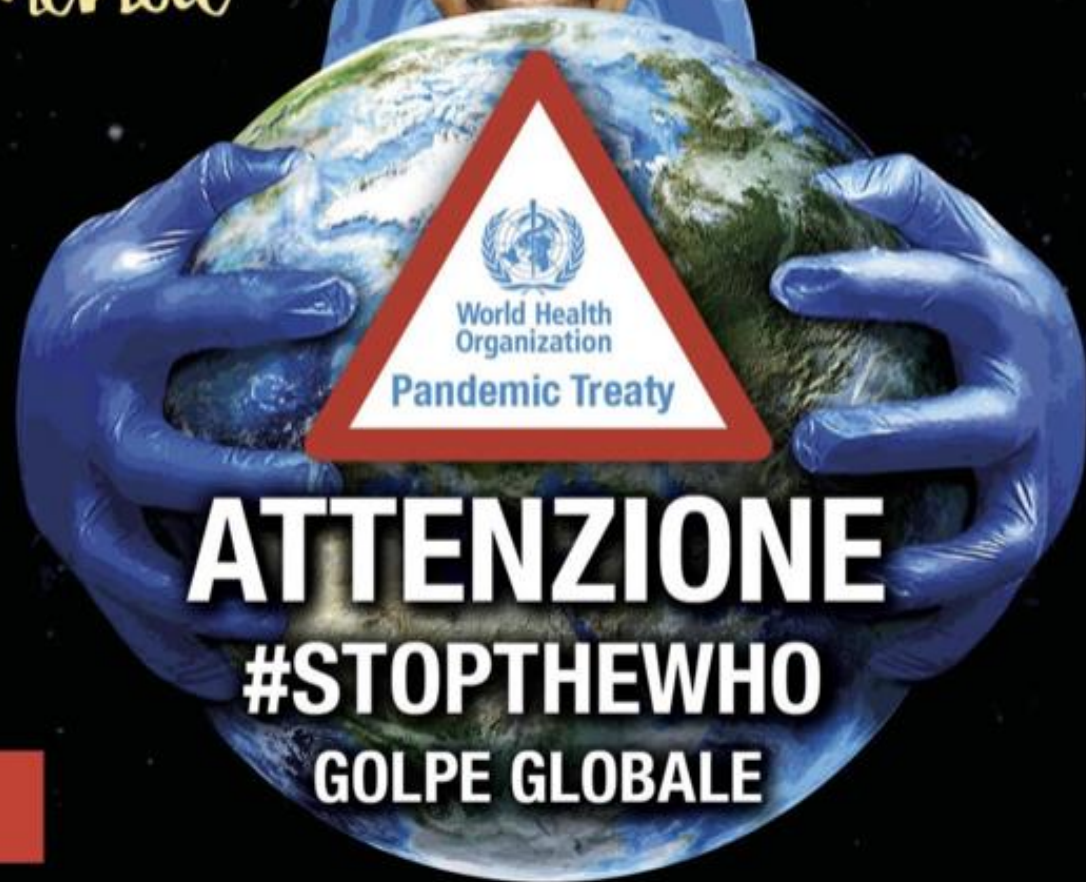
